GENERAL EXPLANATION:

No:15/1 34799 Çekmeköy / İstanbul, via notary public, or to our registered electronic mail (KEP) address modiskele@hs01.kep.tr using a secure electronic signature, mobile signature, or an electronic mail address that has been previously notified to us and is registered in our system. Your requests stated in your application will be evaluated and finalized as soon as possible and no later than within 30 days. Our Company reserves the right to request a fee according to the tariff set by the Personal Data Protection Board (if any) for such requests.

Since applications must be made with the information and documents specified in Article 5 of the Communiqué on the Principles and Procedures for the Request to Data Controller, the following information and documents must be attached to your application; otherwise, it may not be possible to consider your request:

- a) Name, surname, and if the application is in writing, signature,
- b) T.R. ID Number for Turkish citizens; for foreigners, nationality, passport number or if any, ID number,
- c) The residence or workplace address for notification,
- ç) If available, your email address, telephone number, and fax number for notification,
- d) Your subject of request,

Additionally, any relevant information and documents regarding the subject matter should be attached to the application.

Depending on the nature of this form and your request, you must provide us with the requested information and documents completely and accurately. Failure to provide the requested information and documents in the required manner may result in difficulties in our Company's conducting a thorough and qualified investigation of your request. In such a case, our Company's legal rights are reserved. Therefore, you must submit this form, depending on the nature of your request, in full and including the requested information and documents.
