

INFORMED CONSENT FORM REGARDING THE PROCESSING OF PERSONAL DATA

This Consent Form has been prepared as an annex and integral part of your existing employment contract in the context of the processing, storage, and sharing of the "Personal Data" of natural persons, as regulated by Law No. 6698 on the Protection of Personal Data ("Law No. 6698").

Under this "Informed Consent Form" and within the scope of Law No. 6698, "Personal Data" refers to all kinds of personal data that fall within the scope of obtaining a quote from our company and subsequently signing a contract and/or entering into a commercial relationship with you—specifically, "your identification information, contact information, business partner transaction information, transaction security information, and, in the event of a commercial collaboration between the parties, your bank account information, IBAN number, current account information, account reconciliation, and other payment information." These data may be obtained in written, verbal, audio, or electronic form.

In its capacity as Data Controller, our Company hereby declares that Personal Data will be processed, recorded, stored, safeguarded, updated as necessary, and transferred, in accordance with the manner and conditions detailed in the information text; and we inform you that any transaction carried out on Personal Data by our Company will be deemed processing of personal data.

Your collected personal data are processed under the following legal grounds: they are explicitly stipulated by law; it is necessary to fulfill a legal obligation; it is necessary for the establishment or performance of a contract; it is necessary for the establishment, exercise, or protection of a right (pursuant to Articles 5/2-a, 5/2-ç, 5/2-c, and 5/2-e of Personal Data Protection Law No. 6698).

We inform you that your Personal Data will be stored under all applicable legal regulations for the required periods and conditions, and will be automatically destroyed, deleted, or anonymized at the end of these statutory periods.

You may submit to our Company any requests related to your rights determined under Article 11 of the Personal Data Protection Law No. 6698.

In light of the explanations provided above, I accept that I have first been presented with the separate Information Text and that I have read and understood this present Consent Form provided thereafter, and that the following declaration of consent is made in this manner.

I hereby **explicitly consent**, of my own free will and without any coercion, to the collection of my personal data and/or sensitive personal data in accordance with Law No. 6698 on the Protection of Personal Data—whether by automated or non-automated means, and whether in writing, in print, or in electronic format—and to the partial or complete obtaining, recording, storing, altering, updating, periodically checking, rearranging, and classifying of these data for as long as necessary for the purpose of processing or as stipulated by the relevant legislation or for the duration determined by the legitimate interests of our Company. I also consent to the deletion,

destruction, or anonymization of these data by our Company at the end of the period specified in the legislation or, in the absence of such determination, at the end of the period required by the legitimate interests of our Company.
